

The HA04 Outdoor Appliance Module is a Z-Wave[™] enabled device and is fully compatible with any Home Settings network and any Z-Wave[™] enabled network. Z-Wave[™] enabled devices displaying the Z-Wave[™] logo can also be used with Home Settings modules and controllers regardless of the manufacturer, and Home Settings modules and controllers can also be used in other manufacturer's Z-Wave[™] enabled networks. Each module in a Home Settings network is designed to act as a repeater. Repeaters will re-transmit the RF signal to ensure that the signal is received by its intended destination by routing the signal around obstacles and radio dead spots.

INSTALLATION

- 1. Plug the **HA04 Outdoor Appliance Module** into a 120VAC, 60Hz outlet.
- 2. Plug lamp or appliance into the module.
- 3. Turn the knob or switch on the lamp or appliance to the ON position.
- To manually turn ON the HA04 Outdoor Appliance Module, press and release the Program/ON/OFF/PROGRAM button. The green indicator LED will turn ON, and the lamp or appliance plugged into the HA04 Outdoor Appliance Module will also turn ON.
- To manually turn OFF the HA04 Outdoor Appliance Module, simply press and release the Program/ON/OFF/DIM button. The green indicator will turn OFF and the lamp or appliance plugged into the HA04 Outdoor Appliance Module will also turn OFF.



If the lamp does not turn ON, check to make sure that the power switch for your lamp is turned to the "ON" position, and check to make sure that your lamp is operating properly. NOTE: This module must be mounted in a vertical position with the receptacle facing downward and with the receptacle not reaching ground level
